To Whom it May Concern:

These are the by-laws as voted on by the board of UpCyclesABQ.

ARTICLE I. Officers, Elections, and Duties.

Section 1. There will be at least three board members of equal standing.

Section 2. Board members are invited or appointed by the current board on an as-needed basis.

ARTICLE II: Membership

Section 1. Any person can be a member of the board.

ARTICLE III. Officers and decision-making.

Section 1. All board members shall maintain equal standing.

Section 2. Board members will serve indefinite terms.

Section 3. New board members will be invited or appointed by the current board at least a 30% vote.

Section 4. Decisions will be made by at least a 30% vote.

Section 5. Amendments to the by-laws shall be made by allowing for debate at two consecutive meetings and voting at a third. Amendments are adopted by a 30% vote.

ARTICLE IV: Meetings of Members

Section 1. Regular meetings shall be held virtually on an as-needed basis.

Section 2. Annual meetings shall be held virtually on the first Sunday of March.

Section 3. Special meetings shall be held virtually on an as-needed basis, 14-28 days from the date of request. Any board member can request a special meeting.

Section 4. Notice of the time and place of meetings of the members, whether regular meetings or special meetings, shall be sent via email to each member of the board. Board members shall be notified not less than seven, nor more than fourteen days before the date of said meeting.

ARTICLE V: Board of Directors

Section 1. The Board of Directors shall consist of the invited or appointed officers of the Corporation. All members of the board shall have equal standing, except some have more equal standing than others.

Section 2. All members of the board must be people.

Section 3. Vacancies may or may not be filled by invitation or appointment.

Section 4. One member of the board shall constitute a quorum.

Section 5. Board members may resign at any time with or without notice.
